- 1. The powers, functions and responsibilities of the Electrol Commission were hijacked and didn't work well the way we think. This is not knew to us for the last 25 years of Sir Pundari's leadership in Kompiam Ambum District. He always appoint his own Returning Officer (RO), ARO, presiding officers and Elections officials in every electionsfor the last 25 years of his term as a MP for Kompiam Ambum. All appointments were done in Port Moresby and always Surprises his people and the Candidates during election times. Always bribery and controlling the Electrol Commission through bribery for the last 25 years. 2022 General Election in Kompiam Ambum went the same way.
- 2. Common Roll Updates are all good but few missed out in all five LLGs, campaign ran well and fine but Sir Pundari use peoples DSIP money to buy votes for the people in Kompiam Ambum. His own House was given name tag ATM becouse in every elections during campaign period Sir Pundari invites voters and gives them money. 2022 Election was the same.
- 3. Counting should be counted at Wabag, Engans Headquarter but he then moved it to Jiwaka. Big foul play in the counting rooms. Many Presiding Officers were bribed. Some presiding officers were not in the counting room and yet Returning Officer asked Sir Pundaris tribesmen to do the counting.

The Declaration was null and void. Didnt follow the Election process and the matter was already registered in the leadership tribunal and it is before the court.
