EXPRESSION OF INTEREST FOR PARLIAMENTARY INQUIRY INTO THE 2022 GENERAL ELECTIONS

I, Songo Nore, am a policy researcher working on freelance basis providing independent policy advice services to clients in both the private and public sector, foreign and domestic, and local level governments. I am expressing my strong ardent interest to participate in the subject above.

Currently, I am engaged as a Trade Finance Consultant for the Euro Exim Bank as an independent contractor working on freelance basis to facilitate global trade via issuance of trade finance instruments like Letter of Credit, Export Credit, Factoring, Insurance, Bank Guarantees, Standby Letter of Credit, Offshore Account Opening in three different foreign currencies (i.e. United States Dollar – USD, Great Britain Pound – GBP, European Euro – EURO), Merchant Banking Services, Bond Management Services, and so on. I served in that capacity as a TFC with EEB since September 2022.

In early 2022, I was engaged as a Research Analyst with Abt Associates Australia under its Macroeconomic Stability Program via Economic Governance and Inclusive Growth Partnership whereby I was seconded to work with the Papua New Guinea Special Parliamentary Committee on Public Sector Reform and Service Delivery. I worked very closely with the Chairman, Hon. Gary Juffa - Governor of Oro, and the Deputy Chairman, Hon. Allan Bird - Governor of East Sepik. Thus, I am acquainted with you. I was given the office space at the Gordons PNG Special Parliamentary Committee on Public Sector Reform and Service Delivery that belonged to the Deputy Chairman (Hon. Allan Bird), during my short-term contract work with EGIG Abt Associates Australia. During the course of my duty, I attended informal and formal inquiries or public hearings at the State Function Room, Parliament House and was tasked to transcribe the public hearings as part of my report. My main task was to critically delve into the medical drug procurement system in the National Department of Health (NDoH) in which I furnished a report titled "A Critical Look at the Medical Drug Procurement and Distribution System with its Quality Control System in Papua New Guinea". I submitted the report of my entire work to Mr. David Sode, Head of the Secretariat PNG SPCPSRSD and to Mr. Kyran Curry, Senior Program Manager, EGIG Abt Associates Australia. I also attended Joint-Parliamentary Committee meetings at Holiday Inn consisting of PNG SPCPSRSD and the Permanent Parliamentary Committee on Public Accounts in which I contributed critical views on both the public financial management system and the health system. Furthermore, I participated in joint-panel discussions with international partners (i.e. Forensic Technology International (FTI) Consulting) and local government agency (i.e. Department of Prime Minister and National Executive Council) in regard to public health procurement system.

With respect to addressing the Committee's Terms of Reference here: 1) Firstly, I am very much interested to conduct research and inquiry into the powers, functions, and responsibilities of the Electoral Commission and related matters to assist the Special Parliamentary Committee on 2022 General Elections as this will be an exciting opportunity to conduct research and write about it, and present the findings at the upcoming 2023 PNG Update Conference at UPNG if consent is given by the Chairman, Hon. Allan Bird. My last work report's abstract with PNG Special Parliamentary Committee on Public Sector Reform and Service Delivery in partnership with EGIG Abt Associates Australia was accepted by the Social Protection Panel of the 2022 Pacific Update Conference Organizing Committee at the Crawford School of Public Policy in the Australian National University, to be presented at the University of South Pacific in Suva, Fiji, between 28th – 30th June 2022. However, I formally withdrawn my participation/presentation due to confidentiality issues surrounding my research work with PNG Special Parliamentary Committee on Public Sector Reform and Service Delivery.

- 2) Secondly, I have actively participated in the 2022 National General Elections including both the regional and open politics in Eastern Highlands Province thus I have some background insight into the problems faced with updating of the common roll or electoral roll, campaigning, voting, the counting, declarations, disputed returns process, and related matters.
- 3) Thirdly, I have some invaluable insight on economic and fiscal issues in PNG, especially, Public Financial Management Acts (PFMA 1995, PFMA 2016 Amendment, PFMA 2018 Amendment, and PMFA 2021 Amendment) and the Public Procurement System (NPA 2018) as a result of my recent work as a Research Analyst with EGIG Abt Associates Australia and PNG SPCPSRSD. Hence, it will help me in the inquiry into the expenditure of electoral funds and related matters.
- 4) Finally, I have witnessed problems encountered by state security personnel (i.e. RPNGC, PNGDF, & PNGCIS) as a result of my active participation in 2022 National General Elections in the Eastern Highlands Province.

I am confident that my personal observations in this 2022 National General Elections including 2017 NGE, when combined with interviews, focus group discussions, international literature reviews, and parliamentary public hearings, will unearth some key findings to find a way forward via strategic recommendations to improve the manner and conduct of the next 2027 NGE by proposing risk management strategies to mitigate election-associated risks, promoting good governance and transparency, and ensure that safe, fair, and free elections is conducted in the future.

My collective professional career working experiences within political environments, academia, private sector, public sector, international financial institutions and organizations, dealings with the business community in PNG as a TFC with EEB, etc. has rendered me with strong engagement skills to be able to interact with a wide range of government, non-government, and donor organizations.
